(“Brasmotor” or the “Company”), in accordance with the Brazilian Securities and Exchange Commission (“CVM”) Rule No. 358, dated as of January 3rd, 2002, as amended, and in addition to the Material Fact dated July 12th, 2016, hereby informs the market that, on November 4th, 2016, CVM granted the registration of the public tender offer to acquire up to 100% of the outstanding common and preferred shares issued by the Company, aiming at the cancellation of Brasmotor’s registry as a publicly held company before CVM (“Offer”).
